The highest rate quoted by the bidder/party above the Upset price shall be accepted and confirmed. The highest bidder is required to deposit 25% of offered amount of the vehicle immediately after the sale is confirmed and the rest amount within 7 (Seven) days from the date of acceptance of tender. If the bidder fails to deposit the balance amount within above stipulated time, bid amount will be forfeited.
